Be sure to include house payments, car payments, utilities, credit cards, child support, alimony, traffic tickets, criminal fines, taxes, loans from family or close friends, tort claims, traffic accidents, creditors who have already repossessed items from you, garnishments, your credit union, persons who have cosigned for you, persons you have cosigned for, rent-to-own contracts, leases for real estate of personal property, bounced checks, collection agencies or attorneys collecting for creditors, etc. Also include all creditors that were once your bills but your ex-spouse should be paying for through a divorce decree. I cannot be responsible for any creditor not listed. I have helped thousands of clients before you. If you leave someone off it will probably backfire on you. If legal papers are filed and you leave someone off on purpose, you can go to Federal Prison.
